1. Manarasishwa Municipality has allocated funds from its own annual program and budget towards the cost of the Supply, Delivery, Installation, Testing and Commissioning of Street Lights within the Municipal Area (Wards No. 1-10), and intends to apply part of the funds to cover eligible payments under the Contract for the same (single contract, not divided into packages/lots). Bidding is open to all eligible as per Section V of bidding document.
2. Manarasishwa Municipality invites bids (hard copy) from eligible bidders for the procurement of **Supply, Delivery, Installation, Testing and Commissioning of Street Lights within the Municipal Area (Wards No. 1-10)** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.
3. Only eligible bidders with the following key qualifications should participate in this bidding:
 - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs 2,70,00,000 (Two Crore Seventy Lakh)**
 - Minimum Work experience of similar size and nature: **at least one (1) contract of similar nature completed within the last ten (10) years, with a value of at least NRs 7,250,000 (Seventy-two Lakh fifty thousand)**
4. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

7. Pre-bid meeting shall be held at Manarasishwa Municipality, Office of the Municipal Executive, Mahottari, Nepal at 11:00 hrs on Ashwin 5, 2083 B.S. (21 September 2026).
8. Sealed bids must be submitted to the office Manarasishwa Municipality, Office of the Municipal Executive, Mahottari, Nepal before 12:00 hrs on Ashwin 16, 2083 B.S. (02 October 2026). Bids received after this deadline will be rejected.
9. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 hrs on Ashwin 16, 2083 B.S. (02 October 2026) at the office of Manarasishwa Municipality, Office of the Municipal Executive, Mahottari. Bids must be valid for a period of Ninety (90) days from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs 5,00,000 which shall be valid for 30 days beyond the validity period of the bid (i.e. valid until Magh 16, 2083 B.S. / 30 January 2027)
10. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
