- 5. Pre-bid meeting shall be held at Municipality Hall at 11<sup>th</sup> March. 2020.
- 6. Sealed bids must be submitted to the Manarasishwa Municipality,Office of the Municipal Executive, Mahottari by hand on or before 12:00 AM on Date mentioned in the table above. Bids received after this deadline will be rejected.
- 7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 PM on **Date mentioned in the table above** at the Manarasishwa Municipality, Mahottari. Bids must be valid for a period of on **Date mentioned in the table above** after bid opening and must be accompanied by a bid security from valid Bank in the prescribed format of the bid security amounting to a minimum of as mentioned in the Table above which shall be valid for 30 days beyond the validity period of the bid.
- 8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- 9. Bidders are advised to visit site and assess the actual site conditions before submitting their bid.
- 10. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
- 11. Information or data submitted by the bidder which is either incomplete or unclear or not substantiated by supporting documents shall not be considered for evaluation.
- 12. Bidders are required to specify the total price of the Bid in the Letter of Bid and the Bid Price in the Bill of Quantities. Failure to specify the total price of the Bid in the Letter of Bid and the Bill of Quantities shall be ground for declaring the bid non responsive.

- 13. Manarasishwa Municipality, Office of the Municipal Executive ,Mahottari receive the right to amend and correct at any time in case of discrepancies or errors in bidding document,Tender notice and other documents.
- 14. If any provisions of this document are inconsistent with Public Procurement Act 2063 and public procurement Regulations 2064, the provision of this document shall be void to the extent of such inconsistency and the provision of PPA and PPR prevail.
